Re: Apprenticeship Program Requirements for CCTA to Associate Teacher Classification

Dear Wendy:

This is to confirm the agreement of the Sacramento Employment and Training Agency (SETA) and the American Federation of State, County and Municipal Employees District Council 57, Local 146, AFL-CIO (AFSCME) to a letter of understanding regarding mandatory education requirements for continuation in the classification of Associate Teacher (AT) for employees who do not achieve the required educational credits necessary to promote to the class within the prescribed time.

Specifically, it is agreed as follows:

- 1. Apprenticeship employees are hired and enrolled in a program and classification which allows them to obtain the necessary educational requirements for AT while also working with children as additional staff in the classroom.
- 2. If the employee fails a required course they can make it up in the next presentation so long as it is successfully completed in accordance with the attached chart.
- 3. An employee may not be more than one (1) course behind at any point to remain in the apprenticeship program.
- 4. If the employee fails to successfully complete and receive six (6) units of required courses within the allotted time they will fail the apprenticeship program and be released from employment with no right of appeal.

- 5. If the employee successfully completes and receives six (6) units of required courses, but does not complete the apprenticeship program, then they may be promoted on probation to the AT I classification. The employee does not have the right to return to the Child Care Teacher Assistant (CCTA) classification upon failure of probation in the AT class.
- 6. Successful completion of the apprenticeship program includes completion of twelve (12) units of prescribed coursework and obtaining a permit at the AT level. Upon completion of the apprenticeship program, the employee will be promoted to the AT III classification.
