

2024 Federal Poverty Income Guidelines (FPIG)

CSBG Income Eligibility: A household is eligible for CSBG services if their combined income from all sources, except food programs, falls at or below FPIG for the number of persons in the household. Additionally, the household must reside in Sacramento County or be unhoused and seeking services in Sacramento County.
